CentraCare Health System added 240 employees in Fiscal Year 2012. And 142 in FY 2011. And 61 in FY 2010. That's a total of 443 new people joining the system over the past three years – for a total of 6,914 employees. Those hires include highly skilled professionals such as physicians, nurses, phlebotomists, pharmacists and therapists, as well as a wide array of support personnel in areas such as environmental services and administrative support. CentraCare Health System's annual economic impact on Central Minnesota has been estimated at more than \$1.3 billion.



# *Peace of mind . . . priceless*

Jean Cobb suffered from various mini strokes throughout her life. When she moved to Clarissa in 2004 to be closer to her family, she was diagnosed at CentraCare Health System - Long Prairie with atrial fibrillation by Cardiologist Howard Zimring, MD, CentraCare Heart & Vascular Center.

Jean, 66, arranged to make monthly payments for the care she received. The payments became difficult with Jean's fixed income.

"A billing office representative called me about a program I could apply for," Jean said. "It's a great program that helps patients who do not have the money to pay for health care needs. My heart was relieved."

Jean was eligible for charity care and her health care bills were waived.

"It gives me great pleasure to be able to work with our patients who need financial assistance and peace of mind, so we can continue to improve the health of every patient, every day," said Pam Kraker, Patient Account Representative for CentraCare Health System - Long Prairie and Melrose.

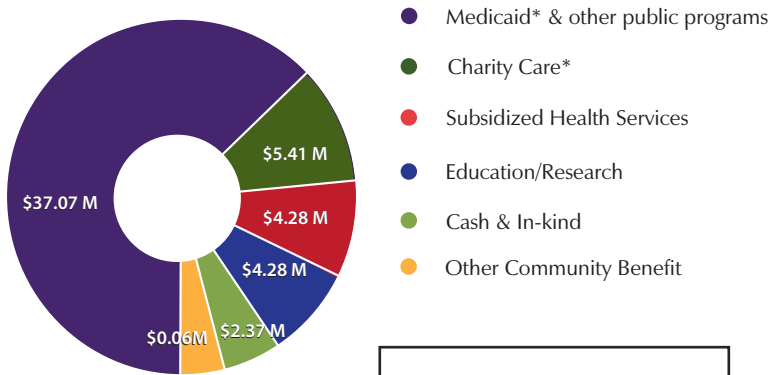

## Health care on the banks of the mighty Mississippi

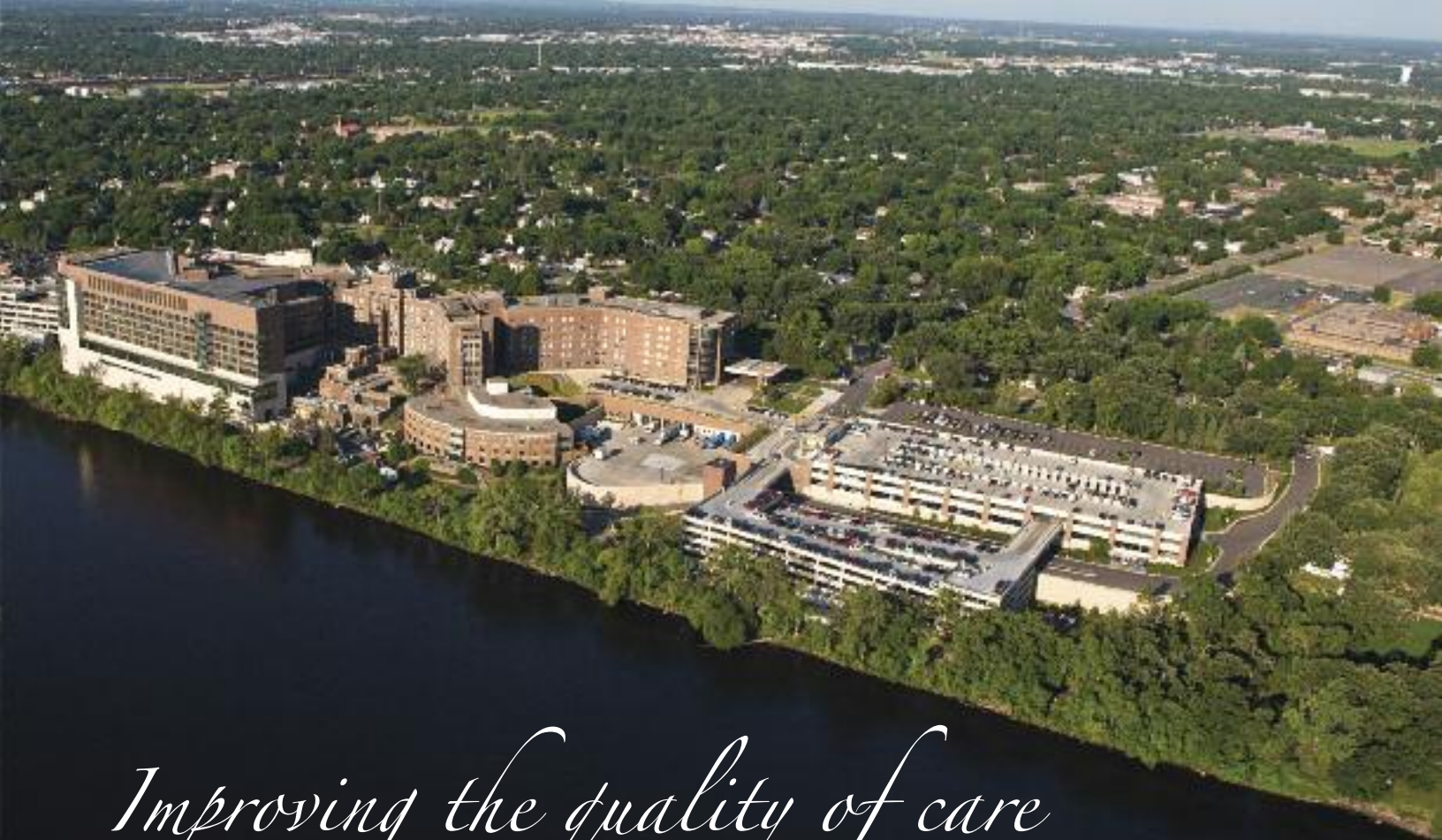
St. Cloud Hospital's 360,000-square-foot expansion was designed to take advantage of its proximity to the Mississippi River. Most of the private patient rooms and family lounges offer spectacular panoramic views of the gorgeous Mississippi as well as the stately trees along its banks.

The building includes 188 windows, most of which face east, toward the river. The brick exterior was designed to complement the original 1926 structure, which is still in use, as well as numerous additions completed over the decades.

Libby Wenderski, RN, Medical Progressive Care Unit coordinator, overheard a patient's family member say "I feel like I am trolling in my boat. I wish I had my fishing pole right now. The view is amazing."







# *Improving the quality of care*

Spacious rooms . . . soothing earth tones . . . A five-star hotel? No, it's the new surgical suites in the St. Cloud Hospital expansion.

The 10 operating rooms, at nearly 750 square feet each, are equipped to bring data, diagnostic images and video closer to the surgeon and staff — allowing staff to make decisions during surgery without having to leave the patient's side.

One surgical suite is a hybrid specially equipped for complex vascular cases such as aneurysms, carotid stent placement and stroke intervention. Interventional Neurologist Muhammad Fareed Suri, MD, with CentraCare Clinic, specializes in diseases and injuries involving the blood vessels of the brain and recently joined the St. Cloud Hospital medical staff.



# *Changing her pace after triple bypass heart surgery*

As a person who has run multiple marathons in the past five years and worked long hours as a tax accountant, Carol Halvorson, age 67 of Clearwater, knew something was seriously wrong when she became winded walking across the room in February 2011.

She saw her primary doctor, who ordered a stress test followed by an angiogram. The next day, she underwent triple bypass surgery at CentraCare Heart & Vascular Center at St. Cloud Hospital.

“A nurse called me right after my angiogram and convinced me that I needed to come in right away,” Carol said. “I handed my staff the stack of appointments for the day, and said I had to go.”

Five weeks after surgery, Carol was back at the office finalizing taxes for her clients at Clearwater Tax & Accounting Service.

“Dr. (Richard) Backes and Dr. (John) Castro were both wonderful,” Carol said. “I can’t say enough good things about them.”

Angels were out in force on April 15 when Kylie Applen, 8, nearly lost her life in an auto accident. Fortunately, Kylie had fallen asleep and was leaning over in the back seat when the car hydroplaned and hit a guard rail that pushed through the side window.

An ambulance just happened to drive by the accident scene to rush Kylie, her dad and another passenger to St. Cloud Hospital's Emergency Trauma Center.

Kylie's mom, Chris Scander, remembers getting the call exactly at 6:29 p.m.

"I could hear Kylie screaming 'I want my mommy,' and it was the most terrified I have ever been," said Chris of Ottertail, Minn.

"The care at St. Cloud Hospital was unbelievable," Chris said. "The staff was incredible. Dr. (Kurt) Martinson and Dr. (Mitchell) Kuhl took the time to explain everything clearly. The nurses were so compassionate and caring. It was the little things like the nurse finding a brush and hair ties to fix Kylie's hair that meant so much. I can't thank them enough."

After just four days in the hospital, with her pelvis broken in three places by the seat belt and a broken finger, Kylie was able to go home where she spent six weeks recovering. The final day of using crutches, Kylie took off running, yelling, "I am free."
